Changes to Academic Regulations 2024/2025 (Taught)

This document provides details of the substantive changes that have been made to the university's academic regulations for taught programmes for 2024/2025. Please note that it would be expected that students liaise with their programme team in the first instance if they have questions regarding the regulatory framework.

1. Format and Style Changes
